## Application for Summer 2008

### Direct Stafford & PLUS Loans

Your period of enrollment for the Summer 2008 starts with the first day of the May Interim, May 19, 2008 and ends with the last day of the Second Summer Session, August 15, 2008. Undergraduate student loans may be certified for students enrolled for at least **six** semester hours. Graduate student loans may be certified for students enrolled for at least **four** semester hours. Any combination of courses taken in the 3-Week May Interim, 8-Week May Interim, First or Second Sessions to total 6 or 4 semester hours respectively, will be considered. Students enrolled in Bradley's Summer Abroad Programs meet the credit hour requirement.

The summer period of enrollment is the first term of the 2008-2009 academic year. The amount of Stafford Loan borrowed will affect the amount available for the remainder of the academic year. If you borrow the statutory maximum allowed, it precludes eligibility in the subsequent 2008-2009 academic periods.

Eligibility is determined by using the results from your 2008-2009 FAFSA. If you will meet graduation requirements during the summer, you will need to complete a 2008-2009 FAFSA even though you will not be enrolled during the Fall and Spring Semesters.
